班颂德皇家师范大学(泰国)与广西国际商务职业技术学院(中国)同意建立国际教育合作,此合作基于平等、互惠、公平和自愿原则,同时也遵守中华人民共和国和泰国法律法规。甲方与乙方同意建立以下国际教育合作:

Bansomdejchaopraya Rajabhat University (Thailand) and Guangxi International Business Vocational College (China) shall agree to establish the international educational cooperation based on the principles of equality, reciprocity, fairness and voluntariness, while abiding by the laws and regulations of both the People's Republic of China and Thailand. Party A and Party B have agreed to establish international educational cooperation as the following:

- 1. 联合开展学士、硕士、博士学位课程
- 1. Jointly work together on courses of bachelor's, master's and doctoral degree programs.
- 1) 甲方负责课程设置和教学方案, 乙方负责推荐项目人员。
- 1) Party A would be responsible for the curriculum syllabus and teaching program, while Party B would be in charge of recommending project personnel.
- 2) 在遵守中泰两国法律法规的前提下,如乙方条件许可,可联合开设学士、硕士和规课程。
- 2) On the premise of abiding by the laws and regulations between China and Thailand, if Party B's conditions are permitted, both parties could set up bachelor's, master's and doctoral courses jointly.
  - 3) 甲方将录取乙方推荐的符合条件的师生到甲方攻读硕士及博士学位,并为乙方师生

理签证及入学等相关手续提供帮助。

- 3) Party A would recruit qualified students and faculties recommended by Party B to pursue master's or doctoral degree in Party A. Party A should provide help for Party B's students and faculty members in dealing with visa application and admission documents.
  - 4) 乙方师生赴甲方攻读硕博士学位的学费及其它杂费另行约定。
- 4) The tuition fees and other charges of Party B's students and faculty members will be decided by another agreement.
- 5) 甲方颁发的硕士及博士学历学位符合泰国教育部的要求和规定,学生获得甲方颁发的硕士及博士学历学位且满足中华人民共和国教育部留学服务中心关于学历学位认证的时间规定后可获得中华人民共和国教育部留学服务中心的认证。
- 5) The master's degree and doctoral degree issued by Party A shall meet the requirements and regulations of the Ministry of Education of Thailand. Students who have obtained the master's degree and doctoral degree issued by Party A and meet the time requirements about academic degree certification of Chinese Service Center for Scholarly Exchange (CSCSE) can obtain the certification of CSCSE.
  - 6) 甲方将根据班颂德皇家师范大学入学条件优先招收乙方推荐的师生。
- 6) Party A would provide priority regarding recruiting students or faculties recommended by Party B, according to the admission conditions of Bansomdejchaopraya Rajabhat University.
- 7) 为便于教学和师资交流,乙方推荐学生后,可派遣部分师资前往甲方做师资交流,如符合甲方要求可聘请为校外硕士生指导老师或博士生指导老师。
- 7) For the sake of facilitation on teaching and teachers' exchange, Party B may dispatch some teachers to Party A aiming at faculty exchange after making recommendations. If the exchange faculties completely meet Party A's requirements, they could be hired by Party A as external tutors for masters or doctoral students.
  - 8) 深入硕士点或博士点合作。
  - 8) Strengthen cooperation between the two universities in master's or doctor's degree programs.

  - 2. Short-term cultural exchange activities
  - 1) 双方根据自身需求开展短期学生和教师交流活动。
- 1) Both parties can carry out short-term student and teacher exchange activities according to their own needs.
  - 2) 双方可根据自身需求和条件开展学术或短期培训课程。
- 2) Both parties can carry out academic or short-term training courses according to their own needs and conditions.
  - 3. 争议解决方式

## 4. 协议时效和生效条件

### 4. Agreement commencement date and effective conditions

本协议一式二份, 协议从签字当日起生效, 协议有效期四年, 到期如双方有意继续合 可顺延四年,如任何一方想终止协议需提前 60 天以书面形式告知。

The agreement shall be made in duplicate, effective from the date of signing. The agreement is valid for four years. If both parties intend to continue cooperation at the expiration of the term, it can be extended for another four years. If either party wants to terminate the agreement, it shall be notified in writing 60 days in advance.
