

Memorandum of Understanding

between

Bansomdejchaopraya Rajabhat University
Bangkok, Thailand

and

International House Vancouver
Vancouver, British Columbia, Canada

The purpose of this Memorandum of Understanding (MOU) is to foster strategic discussion and cooperation between Bansomdejchaopraya Rajabhat University (BSRU) and International House Vancouver (IHV) in exploring opportunities for a formal partnership in the areas of English as a Second Language (ESL) education, academic bridging programs, student recruitment, English qualification training, and teaching and research opportunities to the mutual benefit of both parties.

WITNESSETH THAT:

Whereas BSRU being a public post-secondary institution duly recognized by the Province of Bangkok and established under the Bansomdejchaopraya Rajabhat University Act, wishes to engage with International House Vancouver offering Cambridge University certified English teacher training programs, academic programs, facilities and partnership opportunities globally; and

Whereas IHV is a duly registered corporation in the Province of British Columbia and approved by the BC Private Training Institution Branch (PTIB). IHV wishes to engage with BSRU in the provision of academic programming and research, teacher and English language training, and business development opportunities.

NOW, THEREFORE, in consideration of the mutual promises herein contained and subjected to the terms and conditions herein, the parties agree as follows:

1. Objectives

a) Articulate IHV's ESL program, Academic Foundations Program (AFP), teacher training (TESL/TESOL, CELTA and DELTA of Cambridge University), and Business programs, including co-op to BSRU's appropriate undergraduate programs.



- b) Promote IHV English for Academic Purposes (EAP), AFP, and Business programs to the BSRU students and facilitate those students who aspire to come and study in IHV in Canada.
- c) Establish a BSRU Vancouver Project Office at IHV by May 2023.
- d) Support the academic and business needs of both parties.

2. Commitments of BSRU

- a) BSRU will enter into a dialogue with IHV to explore the objectives outlined in Section 1 in a timely manner and subject to available resources, to the extent allowed by law, so as to allow both partners to evaluate each objective properly.
- b) BSRU agrees to review and assess the progress of the dialogue resulting from this MOU and, as appropriate, may enter into specific contractual obligations with IHV where mutual benefit is deemed possible.

3. Commitments of IHV

- a) IHV will enter into a dialogue with BSRU to explore the objectives outlined in Section 1 in a timely manner and subject to available resources, to the extent allowed by law, so as to allow both partners to evaluate each objective properly.
- b) IHV agrees to review and assess the progress of the dialogue resulting from this MOU and, as appropriate, may enter into specific contractual obligations with BSRU where mutual benefit is deemed possible.

4. Term

Subject to Section 5, this MOU is in effect from the date of signing for a period of ten (10) years and, upon mutual written agreement of the parties, may be extended for a period that is acceptable to the parties. Both parties agree to a mid-term review of the partnership after the fifth year.

5. Termination

Either party may terminate this MOU for convenience by providing the other party six (6) months prior written notice.

6. Amendment

This MOU may be amended, modified, or supplemented only by a written agreement signed by each party.

7. Binding Statement

The matters recorded in this MOU represent the expression of sincere intention by the Parties. Until such intention is embodied in a binding written agreement, such expression of intention



will not be legally binding upon the Parties. The parties will each be responsible for and bear their own costs related to the due diligence required for the project.

This agreement is executed effective as of February 20, 2023.
