## 二，合作期限及相关事项 VALIDITY OF AGREEMENT

1．具体交流项目，由甲乙双方共同协商另行制定详细协议。
Party A and Party B shall jointly negotiate and formulate a separate detailed agreement on specific exchange programs．
2．本办议书自签署之日起生效，有效期限为三年，任何一方欲终止合作关系，提前三个月函告对方。三年期约届满，需重新签署合作协议。
This Agreement shall come into force from the date of signing and is to remain valid for a period of three years． Either party may terminate this Agreement by giving the other party at least three months＇written notice．When the three－year term expires，the cooperation agreement needs to be re－signed．
3．本协议书一式两份，由双方各执一份。当中文与英文在内容上产生歧义时，以中文为准。
The parties shall sign two bilingual originals of this Agreement．Each party shall retain one original．Any conflict between the English and Chinese texts will be resolved in favour of the Chinese text．
